

# Internal Security Fund Police

## ACHIEVING THE KEY OBJECTIVES

The ISF Police contributes to ensuring a high level of security in the EU. Within this general objective, the fund activities focus on two specific objectives.

- **The fight against crime.** Combating cross-border, serious and organised crime, including terrorism, and reinforcing coordination and cooperation between law enforcement authorities and other national authorities of Member States, including with the European Union Agency for Law Enforcement Cooperation and other relevant EU bodies, and with relevant non-EU and international organisations.
- **Managing risks and crises.** Enhancing the capacity of Member States and the EU to effectively manage security-related risks and crises, and being prepared to protect people and critical infrastructure against terrorist attacks and other security-related incidents.

For the 2014–2020 period, slightly over EUR 1 billion was made available for funding activities under the ISF Police instrument, of which EUR 863 million is channelled through shared management and EUR 342 million through direct management.

Concrete activities funded through this instrument include a wide range of initiatives, such as setting up and running IT systems, acquiring operational equipment, providing training schemes and ensuring administrative and operational coordination and cooperation.

## THE FUND BENEFICIARIES

All Member States except Denmark participate in the ISF Police. Examples of beneficiaries include state and federal authorities, local public bodies, non-governmental organisations and private and public law companies.

## ISF Police project: National contact points: sharing international know-how (AT/2016/PR/0040)

The goal of this project is the sustainable optimisation of the processes involved in information exchange between cross-border police in order to sustainably reduce processing time. It involves:

- improving communication in the fight against crime with the following countries/regions: Azerbaijan, Georgia, Moldova, Ukraine, the Black Sea states, the Caucasus region, the Western Balkans (Albania, Bosnia and Herzegovina, Kosovo <sup>(1)</sup>, Montenegro, North Macedonia, Serbia) and, in particular, the EU Member States Bulgaria, Croatia and Romania;
- improving international police cooperation;
- exchanging and jointly developing best-practice models.

<sup>(1)</sup> This designation is without prejudice to positions on status, and is in line with UNSCR 1244/1999 and the ICJ Opinion on the Kosovo declaration of independence.

The project brings the Network of the Police Directors of the Southeast Europe Police Chiefs Association (covering Albania, Bosnia and Herzegovina, Bulgaria, Montenegro, North Macedonia, Republika Srpska, Romania and Serbia) closer to the European security strategy.

## ISF-Polizeiprojekt: Informationsaustausch der „National Contact Points“: Internationales Know-how – „Personal-Sharing“ in der Region (AT/2016/PR/0040)

Das Ziel des Projekts ist die nachhaltige Optimierung der Prozesse im Bereich des grenzübergreifenden polizeilichen Informationsaustauschs, um dadurch eine nachhaltige Reduktion der Prozesszeiten zu bewirken: Das Projekt zielt auf Folgendes ab:

- Verbesserung der Kommunikation im Bereich der Kriminalitätsbekämpfung mit folgenden Ländern/Regionen: Aserbaidschan, Georgien, Kaukasusregion, Republik Moldau, Schwarzmeer-Staaten, Ukraine, Westbalkan (Albanien, Bosnien und Herzegowina, Kosovo <sup>(1)</sup>, Montenegro, Republik Nordmazedonien, Serbien) sowie schwer-


punktmäßig die EU-Mitgliedstaaten Bulgarien, Kroatien und Rumänien;

- Verbesserung im Bereich der internationalen polizeilichen Zusammenarbeit;
- Austausch und gemeinsame Entwicklung von Best-Practice-Modellen.

Durch dieses Projekt wird das „Netzwerk der Generaldirektoren“ der SEPCA - Southeast Europe Police Chiefs Association (Albanien, Bosnien und Herzegowina, Bulgarien, Montenegro, Nordmazedonien, Republik Srpska, Rumänien und Serbien) – näher an die europäische Sicherheitsstrategie herangeführt.



## ISF Police project: Protecting Brussels's critical infrastructures (BE/2016/PR/1802)



Due to the many national and international events taking place in Brussels, as well as the presence of critical EU institutions and infrastructure, there is an urgent need for additional, modern support measures in order to allow the Brussels Capital Police to provide effective protection. This project aims to develop a next-generation prototype of *cheval de frise* (a mobile defensive barrier) and to test it extensively in the field, after which it is envisaged that 60 units will be ordered during the first phase. Secondly, the project aims to develop a modified transport vehicle (suitable for transporting the *chevaux de frise*) in the form of a specially adapted truck fitted with a mobile barrier, which would allow the police to flexibly anticipate changes in the routes of demonstrations. Lastly, the project plans for the renewal of personal

protection gear for the police personnel involved (fire-retardant equipment, helmets, gas masks, gloves, etc.).

## ISF Politieproject: “Protecting Brussels Critical Infrastructures” (BE/2016/PR/1802)

Gezien de vele evenementen die plaatsvinden in Brussel en de aanwezigheid van cruciale EU-instellingen en infrastructuur, is er een dringende behoefte aan aanvullende moderne ondersteuningsmiddelen, opdat de Politiezone Brussel-Hoofdstad-Elsene haar beschermstaak adequaat kan vervullen. Dit project is erop gericht een nieuw model van “Friese ruiters” (mobiele hekwerkversperringen) te ontwikkelen en uit te testen in het veld, waarna in een eerste fase een zestigtal eenheden kan worden besteld. Daarnaast beoogt het project

de ontwikkeling van een aangepast transportvoertuig in de vorm van een specifieke vrachtwagen (eveneens geschikt voor het vervoer van de Friese ruiters) die is voorzien van een mobiel hekwerksysteem, waarmee op flexibele wijze kan worden geanticipeerd op afwijkingen van de reisweg door manifestanten. Tot slot voorziet het project in de vernieuwing van persoonlijke beschermingsmiddelen voor het betrokken politiepersoneel (brandvertragende uitrusting, helmen, gasmaskers, handschoenen enz.).



## ISF Police project: Decreasing the level of corruption in patrol and traffic police by installing video surveillance in police vehicles (BG/2015/PR/0003)

This project aimed to increase the effectiveness of anti-corruption measures and decrease the level of corruption among patrol and traffic police officers through the installation of an integrated mobile video surveillance system in police cars.

**Activities.** Installation of an integrated mobile video surveillance system in 600 of the Bulgarian Ministry of the Interior's cars through the delivery, installation and utilisation of hardware and software; training of 8 000 patrol and traffic police officers to work with the integrated system; testing of 50 body-worn video cameras by patrol police officers.

**Results.** Reduction of potential for misconduct by police officers when performing traffic control duties; regular internal control throughout the territory of the country; reduction in reports of corrupt behaviour by police officers; deterrent to offenders on the road.

## ISF проект „Полиция“: Намаляване на корупцията чрез видеонаблюдение (BG/2015/PR/0003)

Проектът цели повишаване ефективността на антикорупционните мерки сред служителите, ангажирани с контрол и безопасност на движението, и намаляване нивото на корупция сред патрулната и пътната полиция чрез въвеждане на видеонаблюдение в полицейските автомобили.

**Действия:** изграждане на интегрирана система за видеонаблюдение в 600 автомобила на МВР чрез доставка, инсталация и пускане в експлоатация на оборудване и софтуер; обучение на 8000 служители от охранителна и пътна полиция за работа с интегрираната система; тестване на 50 носими видеокамери от служители на Охранителна полиция.

**Резултати:** ограничаване на неправомерните действия при осъществяване на пътния контрол за безопасност на движението; постоянен вътрешен контрол на територията на страната; намаляване на сигнализите за корупционно поведение на полицейските служители; възпиращ ефект върху нарушилите на пътя и обществения ред.



## ISF Police project: Strengthening the Ministry of the Interior's capacities: protecting people and critical infrastructures from events that can endanger security, including effective security and risk management and security crises, and combating terrorism (HR/2018/PR/0011)

### Main activities/components of the project.

1. **Equipment.** IT equipment, protective equipment and vehicles, chemical, biological, radiological, nuclear and explosive (CBRN-E) threat detection and neutralisation equipment.
2. **Prevention.** Development of educational and promotional materials and implementation of a preventive campaign.
3. **Education.** Conducting courses, workshops, seminars and exercises and participating in international training and education in other EU Member States.

### Expected results

The procurement of IT equipment will improve the exchange of information, and the procurement of detection and security equipment will improve the ability to detect CBRN-E threats and provide better protection for police officers in charge of first responders.

The implementation of a preventive campaign, using the educational and preventive materials that are created, will raise the level of people's awareness of the dangers of illegal possession

of explosive devices and of the explosive residues found.

Expert conferences, workshops, seminars and conferences will share information, raise awareness of the dangers of terrorism-related offenses and provide practice in relation to CBRN-E threats.

## Projekt ISF Policija: Jačanje kapaciteta Ministarstva unutarnjih poslova u zaštiti ljudi i kritične infrastrukture od događaja koji mogu ugroziti sigurnost, uključujući djelotvorno upravljanje rizicima i krizama koji mogu ugroziti sigurnost, te borbi protiv terorizma (HR/2018/PR/0011)



### Glavne aktivnosti/komponente projekta:

1. oprema: IT oprema, zaštitna oprema i vozila, oprema za detekciju i neutralizaciju KBRN-E prijetnji;
2. prevencija: izrada edukativno-promotivnih materijala i provedba preventivne kampanje;
3. edukacija: provedba tečajeva, radionica, seminara i vježbi te sudjelovanje na međunarodnim treninzima i edukacijama u drugim državama članicama EU-a.

### Očekivani rezultati:

Nabavom IT opreme poboljšat će se razmjena informacija, a nabavom opreme za detekciju

i zaštitne opreme poboljšat će se sposobnost otkrivanja eksplozivnih i KBRN ugroza i omogućiti bolja zaštita policijskih službenika zaduženih za prvi odgovor.

Provedbom preventivne kampanje uz korištenje edukativno-promotivnih materijala podići će se razina svijesti ljudi o opasnostima od nelegalnog posjedovanja eksplozivnih sredstava kao i od pronađenih zaostalih eksplozivnih sredstava.

Na stručnim skupovima, radionicama, seminariма i konferencijama razmijenit će se informacije, podići razina svijesti o opasnosti od kaznenih djela povezanih s terorizmom i uvježbati postupanje u slučaju KBRN-E prijetnje.

## ISF Police project: Strengthening operational capacity for preventing and combating crime (CY/2016/PR/0007)



The aim of this project was to strengthen the operational capacity for preventing and combating crime.

The main activities included covering infrastructure costs and upgrading existing facilities for the needs of the Office for Combating Cybercrime and the Digital Evidence Forensic Laboratory. The project also included purchasing specialised equipment as well as vehicles with technological equipment to meet the needs of different departments of the Cyprus Police, purchasing the services of financial analysts for the needs of the Economic Crime Investigation Office and activities for informing and raising awareness among the public in the areas of, in particular, drug trafficking, the fight against cybercrime and crime prevention.

The variety of the actions delivered (e.g. construction of a training room, purchase of spe-

cialised equipment, vehicles and services, awareness campaigns, research, purchase/renewal/upgrading of forensic tools, etc.) made this project particularly interesting.

## Έργο ISF Police: Βελτίωση της ικανότητας για πρόληψη και καταπολέμηση της εγκληματικότητας (CY/2016/PR/0007)

Στόχος του έργου είναι η ενίσχυση της ικανότητας για πρόληψη και καταπολέμηση της εγκληματικότητας.

Οι κύριες δραστηριότητες περιλαμβάνουν την κάλυψη του κόστους υποδομής και την αναβάθμιση των υφιστάμενων εγκαταστάσεων για τις ανάγκες του Γραφείου Καταπολέμησης Ηλεκτρονικού Εγκλήματος. Το έργο περιλαμβάνει επίσης την αγορά εξειδικευμένου εξοπλισμού και οχημάτων για την αντιμετώπιση των αναγκών των τμημάτων της Αστυνομίας Κύπρου, την αγορά υπηρεσιών οικονομικών αναλυτών για την κάλυψη των αναγκών του Γραφείου

Διερεύνησης Οικονομικού Εγκλήματος και την πραγματοποίηση δράσεων για την ενημέρωση και την ευαισθητοποίηση του κοινού, κυρίως στους τομείς της διακίνησης ναρκωτικών, της καταπολέμησης του κυβερνοεγκλήματος και της πρόληψης του εγκλήματος.

Η ποικιλία των παραδοτέων του έργου (π.χ. κατασκευή αίθουσας εκπαίδευσης, αγορά εξειδικευμένου εξοπλισμού, οχημάτων και υπηρεσιών, εκστρατείες ευαισθητοποίησης, έρευνα, αγορά/ανανέωση/αναβάθμιση δικανικών εργαλείων κ.λπ.) καθιστά το έργο αυτό ιδιαίτερα ενδιαφέρον.



## ISF Police project: Training of service dogs (CZ/2016/PR/0302)

The goal of this project is to increase the effectiveness of the protection mainly of the external borders of Czechia with regard to the illegal transport of cash, drugs and tobacco products. This is achieved through the introduction of service dog training to tackle the illegal transport of cash and by the improvement of dog training for drugs and tobacco products.

Part of the project involves devising a methodology for training dogs to detect cash, purchasing dogs and carrying out follow-up training. Training equipment has been purchased and conditions for dog training have been improved (through the construction of a training hall). Furthermore, dog kennels have been purchased, along with special canine vehicles. The trained dogs will be mainly deployed at particular international airports.

## ISF Policie Projekt: Výcvik služebních psů (CZ/2016/PR/0302)

Cílem projektu je zefektivnit úroveň ochrany zejména vnějších hranic České republiky v oblasti nelegální přepravy finanční hotovosti a omamných a psychotropních látek. Toho je dosaženo zavedením výcviku služebních psů pro boj proti nedovolené přepravě peněz a zlepšením výcviku psů pro drogy a tabákové výrobky.

V projektu je naplánováno vytvoření metodiky pro výcvik psů v oblasti finanční hotovosti, nákup psů, následný výcvik. Budou pořízeny výcvikové pomůcky, vybudovány podmínky (výstavba výcvikové haly) pro zlepšení výcviku psů. Také budou pořízeny kotce pro ustájení

a pro přepravu speciálně upravené automobily pro kynologické účely. Vycvičení psi budou nasazováni zejména na vybraná mezinárodní letiště.



## ISF Police project: E-police – new mobile workstation for police (EE/2015-2018/PR/0012, 0034, 0035, 0054, 0060)

One of the most important tools used by the police in preventing and tackling crime is quick access to information.

With the help of this project, a modern, mobile, user-friendly and sustainable IT solution was developed. The new IT system and on-board workstations enable quick, location-independent access to information. The police search different databases quickly and plan, log and report necessary activities and exchange operative information promptly. The system includes a map application with different information and operative layers and a secure document sharing centre. Feedback from users has been positive. The beneficiary has introduced the e-police solution internationally and there has been noticeable interest. There are plans to further develop and improve the system.

Various modules of the e-police project were also financed from the ISF Borders and Visa and the European Structural and Investment Funds, making it a good example of how projects can

make use of synergies and complementarities between different instruments.




Üks olulisemaid politsei töövahendeid kuritegude ennetamisel ning tökestamisel on kiire ligipääs vajalikule informatsioonile.

ISF-Police'i projekti abil loodi kaasaegne, mobiilne, kasutajasõbralik, vastupidav ja jätkusuutlik IKT-lahendus. Uus infosüsteem ning operatiivsõidukitesse paigaldatud tööjaamat võimaldavad asukohast sõltumatu ja kiiret ligipääsu politseitöös vajaminevale infole. Uue tarkvara abil saab teha kiireid päringuid andmebaasidesse, planeerida vajalikke tegevusi ja vahetada operatiivselt infot. Loodud on kaardirakendus ning turvaline dokumentide jagamise keskus.

Tagasiside kasutajatelt on olnud positiivne. Toetuse saaja on e-politsei lahendust tutvustanud ka rahvusvaheliselt ning huvi selle vastu on märgatav. Süsteemi on plaanis edasi arendada ja täiendada.

E-politsei erinevaid mooduleid rahastati lisaks ka ISF-Bordersist ning struktuurivahenditest. Tegemist on hea näitega projektist, mis loob sünergiaid ja täiendavust teiste rahastustega.



## ISF Police project: Developing the work against human trafficking (FI/2017/PR/500)

The aim of the project was to promote anti-trafficking activities and to increase expertise in identifying and helping victims of human trafficking and in the pre-trial investigation of such crimes in Finland, as well as to promote the equal treatment of victims by the authorities.

The project involved educating pre-trial investigation authorities about the particular characteristics of human trafficking and factors related to investigating such offences. The team produced a study on the trafficking of children and young people in Finland. Seminars were held to raise awareness of the study.

All expectations were exceeded, especially regarding the increased competence of pre-trial investigation authorities. The new national website was redesigned to suit the needs of victims and those involved in helping victims. The study was widely quoted by the media and has led to cooperation with other authorities. Some of the study's recommendations have been incorporated into the government programme.

## ISF Poliisi -projekti: Ihmiskaupan vastaisen työn edistäminen (FI/2017/PR/500)

Hankkeen tavoitteena oli vahvistaa ihmiskaupan vastaista toimintaa ja ihmiskaupan uhrien tunnistamiseen, auttamiseen ja ihmiskaupparikosten esitutkintaan liittyvää osaamista Suomessa ja edistää uhrien yhdenvertaista kohtelua viranomaisissa. Vastaavaa hanketta ei ole Suomessa tehty aikaisemmin.

Hankkeessa esitutkintaviranomaisia koulutettiin ihmiskaupan erityispiirteistä ja ihmiskauppatutkintaan liittyvistä tekijöistä. Sen aikana uudistettiin valtakunnalliset ihmiskauppa.fi-sivut ja laadittiin selvitys lapsiin ja nuoriin kohdistuvasta ihmiskaupasta Suomessa. Selvitystä tuettiin kahdella seminaarilla.

Hankkeessa asetetut tavoitteet, erityisesti esitutkintaviranomaisten osaamisen lisääminen, ylittyivät moninkertaisesti. Uudistetut ihmiskauppa.fi-sivut palvelevat paremmin uhrien ja uhreja auttavien tarpeita. Hankkeessa tehty selvitys sai suuren mediahuomion ja sen pohjalta aloitettiin yhteistyötä muidenkin viranomaisten kanssa. Selvityksen tavoitteita päättyi myös osaksi hallitusohjelmaa.



## ISF Police project: New operational equipment (FR/2014 + 2017/PR/9023 + 9057)



New operational equipment (NEO) is a revolutionary mobile terminal that provides innovative tools to police and gendarmerie officers. NEO tablets and smartphones enable officers to search databases during roadside or identity checks and obtain immediate answers. Prior to this, they had to make these requests by radio and the procedure was often time-consuming. NEO also allows officers to access professional databases and specific applications.

NEO contributes to the fight against crime and terrorism and ensures a high level of security within the EU.

Under the project, 115 000 secure mobile devices were distributed.

The ISF Police project jointly funded:

- the operational testing of NEO (in 2014);

- the strengthening of NEO's central technical platform and the development of applications in areas such as mobile office automation, instant messaging, document fraud, etc. (in 2017).

## Projet «FSI Police»: Nouvel équipement opérationnel (FR/2014+2017/PR/9023+9057)

NEO (nouvel équipement opérationnel) est un poste de travail mobile qui révolutionne le travail des policiers et des gendarmes en mettant à leur disposition des outils innovants. Les tablettes et smartphones NEO permettent aux officiers d'interroger des bases de données lors de contrôles routiers ou d'identité et d'obtenir une réponse immédiate, alors qu'auparavant ces contrôles étaient demandés par radio et pouvaient prendre un certain temps. NEO donne également accès aux bases de données professionnelles et propose des applications spécifiques.

NEO lutte contre la criminalité et le terrorisme et contribue à assurer un niveau de sécurité élevé dans l'Union européenne.

115 000 terminaux mobiles sécurisés ont été déployés.

répression de la criminalité, et gestion des crises) a cofinancé:

## ISF Police project: Advanced training in gunshot residue and drug investigation (DE/2017/PR/1628)

Under this project, the competence of forensic technical staff and experts was increased through further training events, and the formation of networks within the respective target groups was promoted. Since the project was aimed at two different target groups with different needs, it was divided into two modules (gunshot residue and drug abuse).

The aim of module 1 was to design, plan and carry out a training programme in the field of forensic investigation of gunshot particles through workshops.

The aim of module 2 was to conduct workshops on the forensic investigation of drugs. The workshops included the topics of sampling strategies, sample preparation and laboratory organisation and management.

By involving the European Network of Forensic Science Institutes, not only national laboratories but also all forensic science institutes belonging to the network throughout Europe were able to benefit from the training programme.

The training centre is fully furnished and equipped with IT tools, software, study stations and a new interactive classroom, which provides the technical conditions for training up to 30 people at once. By the end of the project, a total of 12 training sessions had been held.

The centre offers training sessions to investigators from local and regional police bodies, the students of the Faculty of Law Enforcement at the National University of Public Service and the officers of the Counterterrorism Intelligence and Criminal Analysis Centre. The courses offered by the newly funded centre contribute to rendering the detection of novel forms of crime (e.g. cybercrime) more effective.





## ISF Rendőrség Program: Specializált bűnügyi szakképzési központ létrehozása (HU/2017/PR/0027)

A projekt hozzájárult a kiberbűnözéshez köthető bűncselekmények felderítésével és nyomozásával foglalkozó szakemberek kompetenciáinak fejlesztéséhez, a kiberbűnözés ellen küzdő egységek hírszerzési, adatalemzési és bizonyítékgyűjtési képességeinek növeléséhez egy speciális kiképzési központ létrehozásával (bútorokkal, IT-eszközökkel, szoftverekkel, tanulóállomásokkal), amelynek mentén sor került egy oktatói kabinet kialakítására, amely lehetővé teszi 30 fő egyidejű képzését. A projekt befejezéséig már összesen 12 db képzésre nyílt lehetőség.

A képzésekbe bekapcsolódhatnak a helyi és területi rendőri szervek nyomozói; a Nemzeti Közszolgálati Egyetem Rendvédelmi Karának hallgatói és a TIBEK munkatársai.

A létrehozott kiképző központban zajló képzések eredményeképpen hatékonyabbá válhat a bűnözés újszerű formáinak (kiberbűnözés) felderítése.

This project aims to optimise the operational and investigative capacity of the Arma dei Carabinieri's scientific investigation departments in terms of data sharing between national and international police forces.

The initiative involves the purchase of a 3D Integrated Ballistics Identification System and an integrated system for 3D comparison of cartridges and bullets. The objective is to bring the departments of Rome, Parma, Cagliari and



## ISF Police project: Device for the disposal of explosive devices (LU/2016/PR/0003)

In the event of a bomb threat, defusing an explosive device is often very difficult and poses a huge risk for the bomb-disposal expert and their team.

In such a scenario, the bomb-disposal unit arrives on site equipped with specialised gear consisting of a truck carrying the equipment and towing a bomb containment chamber. This mobile system, used to secure, transport and dispose of explosive devices, consists of

a sealed chamber mounted on a trailer. In the event of a chemical, biological, radiological or nuclear threat, an external decontamination system can be coupled to the vessel, operated by a specialist unit.

The on-site handling is carried out through a remote-controlled bomb-disposal robot, which places the explosive device inside the chamber for defusing followed by controlled explosion.

## Projet «FSI Police»: Dispositif de neutralisation d'engins explosifs (LU/2016/PR/0003)

Dans le contexte d'une menace à la bombe, le désamorçage d'un engin explosif s'avère souvent très difficile et constitue un risque énorme pour le démineur et son entourage.

Dans un tel cas de figure, les démineurs se rendent sur le lieu de la mission munis d'un équipement spécifique composé d'un camion transportant le matériel et pouvant tracter un conteneur à bombes. Ce système de sécurisation mobile, utilisé pour transporter et neutraliser des engins explosifs, est composé d'une chambre étanche montée sur une remorque. Dans un scénario CBRN (chimique, biologique, radiologique et nucléaire), un système externe de décontamination peut être couplé à ce dispositif, manié par un service spécialisé en la matière.

Les manutentions sur place sont confiées à un robot de déminage contrôlé à distance. Ce dernier place l'engin explosif à l'intérieur de la chambre aux fins de neutralisation moyennant une explosion contrôlée.



## ISF Police project: Justice for victims (NL/2015/PR/0007)

Since 1 April 2017, new legislation that improves victim care in the Netherlands has been in force, in accordance with the European directive on minimum standards for victims. The police are usually the first authority to come into contact with a victim. Often, the police are also the only authority.

Attention to victim care has only recently been intensified. The new legislation required the police to take a more victim-oriented approach. As an organisation, the police were not yet fully equipped for this. For example, the term 'victim' was absent from computerised systems. This required a substantial investment in adapting these systems, in addition to the investment needed to attain an adequate level of attention to care for victims at different stages of their contact with police.

The project aimed to prepare the police to provide structural and systematic high-quality victim care in line with legislation and agreements made within the Dutch criminal justice system. This included the development and provision of training. Training was provided to most executive staff, including management. Furthermore, to support victim care, new information and communications technology was developed and existing facilities

were adapted. In line with the aim of supporting victims, information materials were published and translated.

Police officers now know what constitutes good victim care in four key areas: recognising, informing, protecting and restoring. The police are trained and equipped to carry out this care and are supported by adequate IT systems. Victims receive the information they are entitled to in a language they understand.

## ISF Politieproject: Recht doen aan slachtoffers (NL/2015/PR/0007)

Sedert 1 april 2017 is nieuwe wetgeving van kracht, geënt op de Europese richtlijn minimumnormen voor slachtoffers, die de slachtofferzorg in Nederland verbetert. De politie is doorgaans de eerste autoriteit die met een slachtoffer in aanraking komt. Vaak is zij ook de enige.

De aandacht voor het slachtoffer is pas relatief kort geleden geïntensiveerd. De nieuwe wetgeving vereist van de politie een veel meer op het slachtoffer gerichte benadering. De politie was hier als organisatie nog niet volledig op ingesteld en voor toegerust. Zo ontbrak het begrip slachtoffer bijvoorbeeld in de geautomatiseerde systemen. Dit betekende een forse investering in het aanpassen van die systemen en in het verruimen van de aandacht voor het slachtoffer en de handelingen ten behoeve van dat slachtoffer in de verschillende politiecontacten.

Doel van het project was de politie gereedmaken voor het structureel en systematisch aanbieden

van goede slachtofferzorg in lijn met de wetgeving en de afspraken hierover in de strafrechtken-ten. Hiervoor werd een opleiding uitgewerkt die aan nagenoeg alle uitvoerende medewerkers, inclusief hun leidinggevenden, werd verstrekt. Ter ondersteuning van de slachtofferzorg werd nieuwe ICT ontwikkeld of werden bestaande voorzieningen aangepast. Ook is er informatie-materiaal voor slachtoffers ontwikkeld.

Door dit project weten politiemensen inmid-dels wat goede slachtofferzorg inhoudt. Vier aspecten zijn daarbij van belang: erkennen, informeren, beschermen en herstellen. De politie is eveneens opgeleid en toegerust om dit uit te voeren en wordt daarbij met automati-sering ondersteund. Slachtoffers ontvangen in een taal die zij begrijpen, de informatie waar zij recht op hebben. Aldus wordt voldaan aan de voorwaarden van de EU-richtlijn minimum-normen voor slachtoffers, die op 16 november 2015 in werking is getreden.

## ISF Police project: Automatic ballistic system (Evofinder) (SI/2018/PR/0017)

By providing modern methods of forensic processing of traces of firearms misuse, the new ballistic system – Evofinder – allows for better and faster exchange of ballistic information obtained in investigations into international arms trading, from various crime scenes where firearms were used or from sites of terrorist attacks.

The new system provides all the necessary compatibility with existing equipment and databases and is compatible with other Member States' systems. This means it is easier to carry out mutual comparisons of the traces found and, consequently, facilitates easier identification of suspects.

An electronic microscope is used to find and analyse particles generated after the firing of a firearm. Such particles are collected from projectiles and suspects and then analysed and

compared with one another using a scanning electron microscope. Evofinder connects missile traces to the weapon used and to the scene of the shooting, which ultimately serves as a basis for criminal prosecution.




## Projekt ISF – Policija: Avtomatski balistični sistem (EvoFinder) (SI/2018/PR/0017)

S sodobnimi načini forenzične obdelave sledov uporabe strelnega orožja bo omogočil kakovo-stnejšo in hitrejšo izmenjavo balističnih podatkov, pridobljenih v preiskavah mednarodne trgovine z orožjem, na prizoriščih težjih kaznivih dejanj, v katerih je bilo uporabljeno strelno orožje, ali terorističnih napadov.

Novi balistični sistem zagotavlja potrebno kompatibilnost z že obstoječo opremo in obstoječo bazo podatkov ter je povezljiv s sistemi ostalih članic EU. Tako sta omogočena enostavnejše opravlja-

nje medsebojnih primerjav ugotovljenih sledi in posledično lažja identifikacija osumljениh oseb.

Elektronski mikroskop se uporablja za iskanje in analizo delcev, ki nastanejo po streljanju s strelnim orožjem. Ti delci se iščejo na izstrelkih in osumljencih ter nato z vrstičnim elektronskim mikroskopom analizirajo in medsebojno primerjajo. EvoFinder sledi izstrelkov poveže z uporabljenim orožjem oziroma krajem strelskega incidenta, kar se na koncu uporabi kot podlaga za kazenski pregon.



# Internal Security Fund Borders and Visa

## ACHIEVING THE KEY OBJECTIVES

The ISF Borders and Visa's main objective is to contribute to ensuring a high level of security in the EU while facilitating legitimate travel. The two parts of this fund have the following specific objectives.


- **Visa.** The effective processing of Schengen visas by supporting a common visa policy to facilitate legitimate travel to the EU and provide a high quality of service to visa applicants, ensuring equal treatment of non-EU nationals and tackling irregular migration.
- **Borders.** To achieve a uniform and high level of control of the external borders by supporting integrated border management, harmonising border management measures within the EU and sharing information, both among Member States and between Member States and the European Border and Coast Guard Agency (Frontex), in order to halt irregular migration and ensure smooth crossings of the external borders.

For the 2014–2020 period, EUR 2.5 billion was made available for funding activities under the ISF Borders and Visa, of which EUR 1.44 billion is channelled through shared management and EUR 1.06 billion through direct management. EUR 154 million is reserved for the special transit scheme (in Lithuania).

Concrete activities funded include a wide range of initiatives, such as setting up and running IT systems, acquiring operational equipment, providing training schemes and ensuring administrative and operational coordination and cooperation.

## THE FUND BENEFICIARIES

All Member States except Ireland participate in the implementation of the ISF Borders and Visa. The four Schengen area countries (Iceland, Liechtenstein, Norway and Switzerland) also participate. Examples of beneficiaries include state and federal authorities, local public bodies, non-governmental organisations, humanitarian organisations, private and public law companies and education and research organisations.

## ISF Borders project: Document and visa advisors in third countries (AT/20156/PR/0025)

The document advisors form the first line of defence in the fight against illegal migration. In other words, the use of document advisors in third countries provides considerable support for border surveillance and control in the Schengen area countries, since passengers attempting to travel illegally to a Schengen area country can be checked and prevented from entering while they are still in the third country.

The Austrian document advisors are regularly requested by embassies and airlines of many Member States to check the documents of

visa applicants or air passengers. Support for other Member States amounts to up to 50 % of the working hours of individual document advisors.

The document advisor locations in India, Jordan, Moscow and Thailand are currently supported through this project.

Regular training of staff of Austrian embassies and airlines as well as those of other Member States and Schengen area countries is also provided.

## ISF-Grenzprojekt: Einsatz von Dokumenten- und Visaberatern in Drittstaaten (AT/2015/PR/0025)

Die Dokumentenberater bilden den sogenannten ersten Filter bei der Bekämpfung illegaler Migration. Durch den Einsatz der Dokumentenberater in Drittstaaten wird die Grenzüberwachung und Grenzkontrolle der Schengen-Staaten wesentlich unterstützt, da Passagiere, die versuchen, illegal in einen der Schengen-Staaten zu reisen, bereits im Drittstaat überprüft und an der Einreise gehindert werden können.

Die österreichischen Dokumentenberater werden von Botschaften und Fluglinien vieler EU-Staaten regelmäßig zur Überprüfung von Dokumenten von Visaantragstellern bzw. Flug-

passagieren angefordert. Die Unterstützung anderer EU-Staaten macht bis zu 50% der Arbeitszeit der einzelnen Dokumentenberater aus.

Gefördert werden derzeit die Dokumentenberaterstandorte in Moskau, Thailand, Indien und Jordanien.

Regelmäßige Schulungen von Bediensteten der österreichischen Botschaften und Fluglinien wie auch anderer EU-Mitgliedstaaten bzw. assoziierter Schengenstaaten werden ebenfalls durchgeführt.



## ISF Borders project: Automated border control II (BE/2015/PR/0702)

Over the past few years, Brussels National Airport has seen a remarkable increase in numbers of passengers. It is expected that this trend will continue in the near future. This results in additional pressure on the available international border crossing points and their infrastructure. In this regard, automated border control (ABC) systems ('e-gates') are a valuable addition to manual passenger controls at the Schengen borders, helping to manage the increase in passenger flows. Before the start of this project, six e-gates were already in use at Brussels National Airport. This project aimed to purchase and install an additional 15 e-gates, along with covering the maintenance and operational costs of all active e-gates. The project's added value lay in its innovative character, whereby further automatisation of the border control process was coupled with the necessary guarantees in terms of security and quality.



## ISF Borders project: Geautomatiseerde grenscontrole II (BE/2015/PR/0702)

Brussels National Airport kende de voorbije jaren een indrukwekkende toename van het aantal reizigers. De verwachting is dat deze trend zich in de toekomst zal voortzetten. Dit leidt tot extra druk op de huidige internationale grenscontroleposten en de aanwezige infrastructuur. Automatische grenspoortsystemen (zgn. e-gates) kunnen in die zin een aanvulling vormen op de manuele controle aan de Schengengrenzen om zo het stijgende aantal reizigers te kunnen opvangen. Voor aanvang van dit project waren er reeds zes e-gates actief op Brussels National Airport. In het kader van dit project werd voorzien in de aankoop en installatie van 15 aanvullende e-gates, alsook in het onderhoud en de operationele kosten van alle actieve e-gates. De toegevoegde waarde van dit project moet dan ook worden gezocht in het innovatieve karakter ervan, waarbij de verdere automatisering van het grenscontroleproces wordt gekoppeld aan de nodige garanties inzake veiligheid en kwaliteit.



## ISF Borders project: Provision of gas analysers (BG/2015/PR/0004)

This project enhanced the capacity of the Chief Directorate Border Police for border control at the external EU borders and to detect concealed persons in enclosed spaces such as the cargo sections of trucks and in trains when passing border checks.

**Activities.** Provision of technical means for control of trucks and trains at the border crossing points.

**Results.** Delivered and put into use 80 sets of portable devices (gas analysers) that measure carbon dioxide concentration so as to detect concealed persons in enclosed spaces such as the cargo sections of trucks and trains when passing border checks.

The equipment contributes to a high quality of control and protection of the external EU borders, to counteracting illegal migration and to easier and smother border crossings in compliance with the Schengen *acquis*.

## ISF проект „Граници“: Доставка на газоанализатори (BG/2015/PR/0004)



Проектът цели повишаване капацитета на Главна дирекция „Гранична полиция“ за изпълнение на задачите по граничен контрол на външните граници на Европейския съюз, и по-конкретно проверка на товарни моторни превозни средства, влакови композиции и други за наличието на укрити в тях лица.

**Действия:** доставка на технически средства за проверка на товарни моторни превозни средства на граничните контролно-пропускателни пунктове.

**Резултати:** доставени и въведени в експлоатация 80 комплекта преносими устройства за откриване на укрити лица в закрити помещения чрез измерване концентрацията на въглероден диоксид във въздуха (газоанализатори) за проверка на товарни моторни превозни средства на граничните контролно-пропускателни пунктове.

Доставеното оборудване допринася за по-висока степен на контрол и защита на външните граници на Съюза, за справяне с незаконната миграция и за по-леко и без проблемно преминаване на външните граници в съответствие с достиженията на правото от Шенген.



## ISF Borders project: Procurement of service dogs and canine transport vehicles (HR/2018/PR/0013)

**Key challenge addressed by this project.** Securing the external border of the EU by strengthening the control of the state border of Croatia.

### Main activities/components of the project.

- Procurement of 49 service dogs for the detection of drugs or explosives, or for searching for humans or traces of humans.
- Training of dogs in the centre for dog handlers and police dog training.
- Procurement of 49 vehicles for transporting dogs.

**Expected results.** Equipping of border police with service dogs and vehicles for transporting dogs for the detection of drugs or explosives, or for searching for humans or traces of humans.

**What makes this project particularly interesting?** The use of dogs speeds up the process of detecting drugs or explosives and the search for humans or traces of humans during smuggling attempts, i.e. illegal crossings of the state border of Croatia, while the vehicles ensure greater mobility. The protection at the most threatened sections of the external border will be highly improved.

## Projekt ISF Borders: „Nabava pasa i vozila za prijevoz pasa“ (HR/2018/PR/0013)

### Ključni izazov koji se nastoji riješiti:

Osiguranje vanjske granice Europske unije jačanjem kontrole državne granice Republike Hrvatske.

### Glavne aktivnosti/komponente projekta:

1. Nabava 49 pasa za detekciju droge ili eksploziva, odnosno pronađaska ljudskog traga.
2. Obuka pasa u Centru za obuku vodiča i dresuru službenih pasa.
3. Nabava 49 vozila za prijevoz pasa.

### Očekivani rezultati:

Granična policija opremljena psima i vozilima za prijevoz pasa za detekciju droge ili eksploziva, odnosno ljudskog traga.

### Što ovaj projekt čini posebno zanimljivim?

Nabavom pasa ubrzava se postupak otkrivanja droge ili eksploziva te ljudskog traga pri pokušajima krijumčarenja, odnosno nezakonitim prelascima državne granice Republike Hrvatske, dok se vozilima osigurava veća mobilnost.



## ISF Borders project: Emergency reception centre for rescued individuals (CY/2018/PR/0019)



This project concerned the establishment of a temporary reception and short-stay centre in Larnaca, to monitor and provide medical care to up to 300 refugees/migrants rescued in the south-east search and rescue area of Cyprus.

Specifically, there are 13 prefabricated facilities at the centre: one functions as a short-stay room for the rescued individuals, one hosts government services and one hosts medical services. The remaining 10 host the rescued individuals.

The project co-financed the following:

- earthwork, building and electromechanical work to prepare the reception area of the prefabricated facilities;
- the supply of the 13 prefabricated facilities;
- reconstruction of existing sanitary facilities;

- the supply of household furniture and other equipment (beds, chairs, tables, air conditioners, medical equipment, public announcement/alarm system, etc.);
- purchase of two vehicles.

The centre is the first of its kind in Cyprus.

## ISF Borders έργο: Χώρος ολιγόωρης παραμονής διασωθέντων αιτόμων (CY/2018/PR/0019) ISFB CY pic x1

Το έργο αφορά τη δημιουργία στη Λάρνακα κέντρου προσωρινής υποδοχής και ολιγόωρης διαμονής, ελέγχου και παροχής ιατροφαρμακευτικής περίθαλψης μέχρι 300 διασωθέντων προσφύγων / μεταναστών στη Νότια-Ανατολική Περιοχή Έρευνας και Διάσωσης της Κυπριακής Δημοκρατίας.

Συγκεκριμένα, στον χώρο τοποθετήθηκαν 13 προκατασκευασμένα: ένα λειτουργεί ως δωμάτιο ολιγόλεπτης παραμονής των διασωθέντων, ένα φιλοξενεί τις κυβερνητικές υπηρεσίες και ένα τις ιατρικές υπηρεσίες. Στα υπόλοιπα δέκα θα φιλοξενούνται οι διασωθέντες.

Στο πλαίσιο του έργο συγχρηματοδοτούνται τα εξής:

- Οικοδομικές, μηχανολογικές, ηλεκτρολογικές, ξυλουργικές κ.ά. εργασίες για την

προετοιμασία του χώρου υποδοχής στα προκατασκευασμένα.

- Προμήθεια 13 προκατασκευασμένων.
- Ανακατασκευή των υφιστάμενων χώρων υγιεινής.
- Προμήθεια οικιακού και λοιπού εξοπλισμού (κρεβατιών, καρεκλών, τραπεζιών, συσκευών κλιματισμού, ιατρικού εξοπλισμού, μεγαφωνικού συστήματος ανακοινώσεων/συναγερμών κ.ά.).
- Αγορά δύο οχημάτων.

Το κέντρο είναι το πρώτο του είδους του στην Κυπριακή Δημοκρατία.



## ISF Borders project: National border situation centre (CZ/2017/PR/0601)

The aim of the project was to create the National Situation Centre for Border Control as a joint communication centre for the Directorate of Alien Police and the Customs Administration of Czechia, for the effective fulfilment of border protection and border management tasks.

The main activity of the project was a major reconstruction of the premises. The premises were suitably equipped for operational management, with appropriate technology. A data warehouse capable of performing advanced sophisticated analysis was created. Other IT systems for border control and operation of the centre were created or upgraded. The centre is responsible for the operational management of border surveillance and the implementation of operational analysis. It manages IT systems for border protection, such as the European Border Surveillance System (Eurosur), the Affordable

Guided Airdrop System of airspace surveillance, the KODOX system of border control and the passenger data transfer system. The centre fulfils the role of a national control authority in relation to biometric documents.

## ISF Projekt v rámci ISF Hranice: Národní situační centrum ochrany hranic (CZ/2017/PR/0601)

V rámci projektu bude vybudováno Národní situační centrum ochrany vnějších hranic jako společné komunikační centrum pro Ředitelství služby cizinecké policie a Celní správu za účelem efektivního plnění úkolů ochrany a správy hranic.

Předmětem projektu bude provedení zásadní rekonstrukce prostor, účelné zařízení těchto prostor pro operační řízení a vybavení příslušnou technologií.

Dále dojde k vytvoření datového skladu s možností provádění pokročilých analýz a k pořízení/vytvoření/úpravě informačních systémů pro provoz centra a ochrany hranic. Centrum bude odpovědné za operační řízení ostrahy hranic a společné provádění operačních analýz. Dále bude spravovat provoz informačních systémů ochrany hranic, jako je EUROSUR, systém dohledu nad vzdušným prostorem AGAS, systém hranici kontroly KODOX, systém předávání údajů o cestujících. Centrum bude plnit roli národní kontrolní autority ve vztahu k biometrickým dokladům.



## ISF Borders project: Installation of automated border control gates (DK/2015/PR/0001)

ABC gates are part of the national strategy to cope with an increasing flow of passengers crossing the external border at Copenhagen Airport. The ABC gates make the border control procedure more efficient and contribute to smoother border crossings.

Automatiserede grænsekontrolstationer (ABC-gates) er en del af den nationale strategi til håndtering af et stigende passagerantal, der krydsler EU's ydre grænser i Københavns Lufthavn. ABC-gates skal gøre grænsekontrolproceduren mere effektiv og bidrage til en mere smidig grænsekrydsning.

Projektet består af ti ABC-gates, ni er installeret i Københavns Lufthavn, og en er installeret hos Rigspolitiet til uddannelsesformål.

## ISF Borders project: Procurement of watercraft (EE/2016/PR/0041)



As a controller of the external borders of the European Union, Estonia plays an important role in ensuring the reliability and security of the Schengen area. The marine area protected by Estonia covers approximately 36 500 square kilometres, plus a lake and river border with Russia. Proper modern watercraft are needed to respond quickly to border regime violations on waters. In the course of this, the longest and most expensive project of the Estonian ISF, 12 motor boats, two hydro-copters and 10 jet skis have been purchased, and one hovercraft is planned to be purchased. The replacement of depreciated watercraft has increased Estonia's ability to respond to border regime violations at the EU's external sea borders and in transboundary waters. The Police and Border Guard Board is also able to conduct search and rescue operations with more secure and autonomous means during border guard operations.



## ISF Bordersi projekt: Veesõidukite hankimine (EE/2016/PR/0041)

Euroopa Liidu välispiiri kontrollijana on Eestil oluline roll Schengeni ala usaldusvääruse ja turvalisuse tagamisel. Eesti valvatav mereala hõlmab u 36 500 ruutkilomeetrit, millele lisandub veel järve- ja jõepiir Venemaaga. Kaldalt eemal toimuvatele piirirežiimi rikkumistele kiireks reageerimiseks on vaja korralikke kaasaegseid veesõidukeid. Sisejulgeolekufondi Eesti programmi kõige kallima ja pikema projekti käigus soetati 12 mootorpaati, 2 hüdrokopterit, 10 vesiskuutrit ning plaanis on osta ka 1 hõljuk. Amortiseerunud veesõidukite asendamine on tõstnud reageerimise võimet piirirežiimi rikkumistele Euroopa Liidu välismerepiiril ja piiriveekogudel. Samuti suudab Politsei- ja Piirivalveamet viia piirivalveoperatsiooni käigus merekindlamate ja autonoomsemate vahenditega läbi otsingu- ja päästetöid.



## ISF Borders project: Border guards' Russian language skills (FI/2015/2017/PR/1825-1702)

Schengen inspectors who visited Finland shortly before this project urged the Finnish Border Guard to improve its officers' Russian language skills in order for more and more members of staff to be able to conduct thorough entry checks in Russian.

The Finnish Border Guard consequently ran two projects to improve the standard and availability of Russian language courses and to design new teaching resources and methods for the Border and Coast Guard Academy.

Border control personnel can now take Russian lessons at the Border and Coast Guard Academy, at local patrol stations or online.

Some beginners' courses in professional Russian are now run locally, which helps to save money.

The projects have also created opportunities for educational cooperation with, for example, the police. The projects succeeded in their objective of improving the language skills of the Finnish Border Guard staff, thus making cross-border traffic and border controls run more smoothly.

## ISF Borders -projekti: Rajavartijan venäjän kielen osaamisen tehostaminen (FI/2015/2017/PR/1825-1702)



Suomeen tehdyt Schengen-tarkastuksen tuloksesta rajavartiolaitosta kehotettiin kiinnittämään huomiota rajavartijoiden venäjän kielen taidon parantamiseen, jotta yhä useampi rajavartija pystyisi tekemään perusteellisen maahantulotarkastuksen venäjäksi.

Venäjän kielen koulutuksen kehittäminen ja tehostaminen -hankkeissa kehitettiin sekä opetusmateriaaleja että -menetelmiä raja- ja merivartiokoulun venäjän kielen opetuksessa. Nämä luotiin uusia osallistumiskeinoja opiskeluun joko venäjän kielen kursseilla raja- ja merivartiokoululla, paikallisesti vartiostoissa tai verkossa.

Ammattivenäjän peruskurssin opetusta siirrettiin osin paikallisesti toteutettavaksi, mikä toi kustannussäästöjä.

Hankkeen myötä on avautunut opetusyhteistyömahdollisuuksia mm. poliisin kanssa. Tavoitteet rajavartiolaitoksen työntekijöiden kielitaidon parantamiseksi rajanylitysliikenteen ja rajatarkastusten sujuvuuden kehittämiseksi täyttyivät.



## ISF Borders project: France-Visas (FR/2014/PR/0248)

France-Visas is at the heart of the government's project to improve the state's electronic administration. Its objective of making procedures paperless is twofold: to simplify the process for users and to optimise the workload of visa officers.

France-Visas will improve the reception conditions for visa applicants through a permanent resource providing all the necessary information and will increase the capacity to process cases without compromising on

security and migration risk management obligations.

The user is at the heart of the new process. Users have access to a single multilingual portal where they can consult the information relevant to their travel plans and apply for a visa online. In the near future, they will benefit from a completely paperless procedure (i.e. involving electronic attachments, online booking of consular office appointments and, where necessary, online payment of visa fees).

## ISF Borders project: Improved maritime surveillance and control technology for three Federal Police control boats (DE/2017/PR/1717)



The Federal Police deploys several patrol boats for border surveillance and control at the EU's external borders in the North and Baltic Seas. As part of this project, three of these boats were fitted with new optical surveillance and control systems. These systems are suitable for recognising the smallest details in and on the objects inspected, even in poor visibility and from long distances.

Border police surveillance and controls can be carried out from the furthest possible distance from the vessel, even in poor visibility and heavy seas, and the image and video data obtained can be electronically transmitted in real time to other appropriate or local authorities / emergency services.

The improved boats allow the Federal Police to carry out its surveillance and control mandate at the Schengen borders more easily, more efficiently and more comprehensively, even in adverse weather conditions at sea.

The multisensor system allows optical monitoring in nearly all weather conditions, day and night. Object tracking, sector scans and the optional large display showing all the camera

channels make it possible to determine the right source of each image in each situation. In addition, the picture and video data recorded with the system can be transmitted in real time to police control centres, so that they can be made available to other Member States via Eurosur if required.

## ISF-Grenzprojekt: Verbesserte Seeüberwachungs- und Kontrolltechnik für drei Kontrollboote der Bundespolizei (DE/2017/PR/1717)

Die Bundespolizei setzt zur grenzpolizeilichen Überwachung und Kontrolle an den EU-Außengrenzen in der Nord- und Ostsee mehrere Streifenboote ein. Im Rahmen des Projekts wurden drei dieser Boote mit neuen optischen Überwachungs- und Kontrollsystmen ausgestattet. Mit diesen Systemen sind auch bei schlechten Sichtverhältnissen und großen Distanzen kleinste Details an und auf den Kontrollobjekten zu erkennen.

Grenzpolizeiliche Überwachung und Kontrolle können von einem frühestmöglichen Abstand zum Seefahrzeug auch bei schlechten Sichtverhältnissen und starkem Seegang durchgeführt werden. Die erhaltenen Bild- und Videodaten können in Echtzeit elektronisch an andere eigene oder benachbarte Behörden/Einsatzkräfte weitergeleitet werden.

Durch die verbesserten Boote kann auch bei widrigen Witterungsverhältnissen auf See der Überwachungs- und Kontrollauftrag an den Schengen-Seeaußengrenzen besser, effizienter und umfassender wahrgenommen werden.



Das Multi-Sensor-System ermöglicht die optische Überwachung unter nahezu allen Wetterbedingungen bei Tag und bei Nacht. Objekt-Tracking, Sektor-Scan sowie wahlweise Großdarstellung der Kamerakanäle ermöglichen es, für jede Situation die richtige Bildquelle zu analysieren.



## ISF „Borders” Program: Automatizált biometrikus határellenőrző rendszer létesítése (HU/2018/PR/0021)

## ISF Borders project: Renewal of border crossing point equipment (IS/2018/PR/0006)

To comply with a recommendation from the 2017 Schengen evaluation in Iceland, equipment at border control stations has been renewed, including a vehicle equipped to handle border checks in harbours in the Reykjavik metropolitan area.

The vehicle is a mobile border checkpoint intended to strengthen border control in the capital area. The aim of the project was to strengthen border control in the Reykjavik Metropolitan Police jurisdiction, where facilities were limited for border control.

The results of the project include a mobile border checkpoint (the vehicle) with all the equipment necessary to perform border controls. The vehicle is equipped with, among other items, passport and fingerprint scanners, a visa printer, computers connected to the Schengen databases and ID/passport inspection equipment.

Tilkoma bifreiðarinnar er m.a. hluti af viðbrögðum við ábendingum sem gerðar voru í úttekt á þátttöku Íslands í Schengen-samstarfinu. Bifreiðin er færانleg landamærastöð. ## ISF Borders project: Acquisition of two medium-range helicopters (IT/2017/PR/00018)



The project consisted of the acquisition of two multipurpose helicopters to enhance the coastguard's ability to intervene in the event, for example, of people being lost at sea or units in trouble being unable to provide a clear position.

The new helicopters are used for patrolling and activities in the area of search and rescue at sea.

The expected result was a prompt emergency response service in the southern Mediterranean through targeted patrolling and rapid rescue operations.

The helicopters allow the coastguard to overcome critical issues that might arise from the more limited search capacity of small boats' radars, which need direct visual confirmation and which cannot be monitored by the naval vessels with the same level of effectiveness and timeliness.

## Progetto ISF Borders: Acquisto di due elicotteri a medio raggio (IT/2017/PR/00018)

Il progetto prevede l'acquisto di due elicotteri a vocazione multiruolo al fine di potenziare la capacità d'intervento a mare del Corpo in caso, ad esempio, di ricerca dispersi o di unità in difficoltà che non forniscono una posizione certa.

I nuovi elicotteri saranno impiegati in operazioni di pattugliamento dell'area di responsabilità SAR nonché in attività di ricerca e soccorso a mare. Il risultato che si prevede di raggiungere è un servizio di pronto intervento nel Mediterraneo meridionale attraverso attività mirate di pattugliamento e operazioni rapide di soccorso.

L'utilizzo degli elicotteri consentirà di superare le criticità derivanti dalle difficoltà di discrimi-

nazione e scoperta degli apparati tecnici (ad esempio, radar), relativamente ai piccoli battelli che necessitano di una verifica visiva diretta, non monitorabile con eguale efficacia e tempestività dai mezzi navali.



## ISF Borders project: Modernisation of mobile video surveillance system video data flow (LV/2016/PR/0003)

### Key challenge addressed by this project.

Improving the mobile video surveillance system (MVSS) at the sea border, thus improving border surveillance in the country.

### Main activities/components of the project.

- High video data transmission capacity between MVSS objects was ensured (two new facilities for data transmission were installed and the data transmission capacity of six facilities was increased), together with centralised access to both live and archived video surveillance system images among MVSS objects.
- An optical data transmission line between MVSS objects was established, video cameras and servers were purchased and 26 MVSS objects were repaired or modernised, ensuring high-quality video data flow 24/7.

**Expected results.** Ensuring continuous border surveillance through digital video of the coast, port and marine areas regardless of weather conditions and time of day.

**What makes this project particularly interesting?** The results mentioned in the ISF national

programme were ensured: (1) the capacity of data transmission channels between MVSS objects was improved and (2) the MVSS was modernised – 26 MVSS objects were upgraded. In terms of sustainability, the project created the preconditions for implementing a new round of MVSS projects, i.e. it developed the necessary technical infrastructure to replace existing thermal cameras with next-generation cameras without the need for infrastructure investments (cables, optics, etc.).



## ISF Borders project: Schengen information system recast (LI/2019/PR/02)

The Schengen information system (SIS) is an electronic search system for looking up persons and objects, jointly operated by the Schengen area countries. It contains information on persons wanted by police and judicial authorities, persons subject to an entry ban and missing persons, along with stolen objects (e.g. cars or weapons).

The SIS has become an indispensable tool for Liechtenstein's National Police and its Migration and Passport Office, as well as for the Swiss Border Guard, which operates at the border with Austria. It supports the efforts to promote security in Liechtenstein.

The project will further strengthen cooperation and expand the functionalities of the SIS. Different national procedures for the use of the SIS will be harmonised within the Schengen area, especially in terms of crimes related to terrorism and parental child abduction. Besides new search categories for objects, it will be possible for example to store further biometric data in the SIS for identification purposes (e.g. the

DNA of missing persons, handprints, traces of unknown suspects from crime scenes).

The SIS enables efficient cooperation, particularly between migration authorities, police and judicial authorities in the EU and the Schengen area countries, and thus makes an important contribution to ensuring a high level of security.



## ISF-Grenzprojekt: Schengener Informationssystem (SIS) Recast (LI/2019/PR/02)


Das Schengener Informationssystem (SIS) ist ein elektronisches Personen- und Sachfahndungssystem, das durch die Schengen-Staaten gemeinsam betrieben wird. Es enthält Informationen über polizeilich und justiziell gesuchte, mit einem Einreiseverbot belegte oder vermisste Personen sowie über gestohlene Gegenstände (z. B. Autos und Waffen).

Das SIS ist für die Landespolizei, das Ausländer- und Passamt sowie für das an der Grenze zu Österreich tätige Schweizerische Grenzwachtkorps zu einem unverzichtbaren Instrument geworden. Es unterstützt die Arbeit zugunsten der Sicherheit in Liechtenstein.

Mit dem Projekt „SIS Recast“ wird die Zusammenarbeit weiter gestärkt und die Funktionalitäten des SIS werden ausgebaut. Unterschiedliche

nationale Verfahren zur Nutzung des SIS sollen im Schengen-Raum harmonisiert werden, insbesondere im Hinblick auf Straftaten mit Terrorismusbezug sowie die Entführung/Entziehung von Kindern durch einen Elternteil. Darüber hinaus soll beispielsweise die Möglichkeit geschaffen werden, neben neuen Sachfahndungskategorien auch weitere biometrische Daten zur Identifikation (DNA bei Vermissten, Handabdrücke, Tatortspuren unbekannter Tatverdächtiger) im SIS speichern zu können.

Das SIS ermöglicht eine effiziente Zusammenarbeit besonders zwischen Migrations-, Polizei- und Justizbehörden in der EU und den assoziierten Schengenstaaten und leistet somit einen wichtigen Beitrag zur Gewährleistung eines hohen Sicherheitsniveaus.



## ISF Borders project: Upgrading the maritime surveillance system, phase I (LT/2018/PR/2123)



### Key challenge addressed by this project.

Although maritime surveillance system data are available for relevant national authorities, tactical cooperation in the area of sea border control has to be enhanced.

### Main activities/components of the project.

- A new radiolocation surveillance management subsystem has been installed.
- Workstations have been modernised.
- Coastline surveillance equipment is to be integrated (phase II).

**Expected results.** Enhancement of sea surveillance data management and efficient cooperation between national authorities in the field of maritime situational awareness.

**What makes this project particularly interesting?** Its main achievement is the establishment of a new, nationally recognised maritime data

exchange platform for images with common procedures for operation by national authorities according to their different functions. The project was implemented in close partnership with the Lithuanian armed forces (the navy).



## ISF Borders project: Automated border control gates (LU/2017/PR/0005)

The ABC gates project consisted of the implementation of ABC gates at the external border of Luxembourg Airport. This project had two components: firstly, the physical implementation of automated gates at the airport, and secondly, software developments to ensure the smooth functioning of the gates.

The aim of the project was to complement the manual checks on passengers crossing the external border, which are carried out by the staff of the Grand Ducal Police, in order to, in particular, improve the flow of passengers and reduce waiting times. Since they were set up, the ABC gates have been effective in enabling Luxembourg's border guards to cope with the increase in the number of passengers crossing Luxembourg's external border and to improve the passage of travellers across the external border. Furthermore, thanks to the software developments, the ABC gates carry out systematic checks in the

various police databases in accordance with the Schengen Borders Code as modified by Regulation (EU) 2017/458 of 15 March 2017, thus securing the external border.

## Projet «FSI Frontières»: Guichets automatisés de contrôle aux frontières extérieures (LU/2017/PR/0005)

Le projet «ABC Gates» consiste en la mise en place de guichets automatisés de contrôle aux frontières extérieures à l'aéroport de Luxembourg. Depuis leur mise en place, ces guichets ont effectivement permis aux gardes-frontières luxembourgeois de faire face à l'augmentation du nombre de passagers qui franchissent la frontière extérieure du Luxembourg ainsi que d'améliorer le passage des voyageurs par la frontière extérieure. En outre, grâce au développement des logiciels, les guichets automatisés effectuent des contrôles systématiques dans les différentes bases de données de la police conformément au code frontières Schengen tel qu'amendé par le règlement (UE) 2017/458 du 15 mars 2017 afin de sécuriser la frontière extérieure.



## ISF Borders project: Procurement of a third fixed-wing maritime patrol aircraft (MT/2018/PR)

This project entails the design, procurement and commissioning of a new twin-engine fixed-wing aircraft similar in type to those of the current fleet (B200s) and with mission systems capable of conducting and supporting border control missions. The project is intended to improve the operational availability, capability and sustainability of the fixed-wing component of the Armed Forces of Malta and enable them to continue effectively patrolling the EU maritime borders, both by day and by night, and to support other EU border-related missions.

## ISF Borders project: Rigid-hull inflatable boat 2000D3 (NL/2018/PR/0212)

The aim of this project is to provide four brigades of the Royal Netherlands Marechaussee, which are responsible for inspecting boats used for recreational use, with new equipment, namely rigid-hull inflatable boats (RHIBs). The RHIB is a small, fast, manoeuvrable motor boat.

This is in line with the Schengen evaluation action plan on the control of recreational boats. The four brigades in charge of this are those of the Scheldensestromen, South Holland, North Holland and Wadden regions. The new equipment includes six RHIBs, six trailers, six towing vehicles and 132 full-time-equivalent staff. The vessel is equipped with all necessary means of communication, radar systems and optical and sound signalling. In order for the vessels to be transportable, a trailer is supplied. In addition, all vessels are provided with a dedicated towing vehicle capable of towing up to 3 500 kilograms. For this purpose, the vehicle is equipped

with four-wheel drive. Infrastructure is being developed to store the vessel, contributing to its preservation – the existing infrastructure is either insufficient or not present.

## ISF Borders project: RHIB 2000D3 (NL/2018/PR/0212)

Het doel is vier brigades van de Koninklijke Marechaussee die belast zijn met de controle van de pleziervaart, te voorzien van nieuw materiaal, namelijk RHIB's (rigid hull inflatable boat). Dit zijn kleine, wendbare en snelle motorboten.

Hiermee wordt invulling gegeven aan het Actieplan Schengenevaluatie ten aanzien van de controle van de pleziervaart. De vier brigades die hiermee zijn belast, zijn Scheldestromen, Zuid-Holland, Noord-Holland en Waddengebied. Het nieuw materiaal betreft 6 RHIB-vaartuigen, 6 trailers, 6 trekkende voertuigen en 132 VTE. Het vaartuig wordt voorzien van alle beno-

digde verbindingsmiddelen, radarsystemen en optische en geluidssignalering. Om het vaartuig te kunnen verplaatsen, worden de vaartuigen geleverd met een bijbehorende trailer.

Alle vaartuigen worden gecombineerd met een aangepast trekkend voertuig. Dit zal een bus zijn die in staat is om het totale gewicht van 3 500 kg te kunnen verplaatsen. Hiervoor dient de bus te zijn voorzien van vierwielandrijving. Om het vaartuig te kunnen stallen, moet ook in infrastructuur worden voorzien. Dit draagt bij aan het behoud van het vaartuig. De huidige infrastructuur voldoet niet of ontbreekt.



## ISF Borders project: Competence-building for border control (NO/2018/PR/0001)



The results of the Schengen evaluation in 2017 revealed major differences between the various police districts in terms of access to necessary knowledge and expertise in the field of border control.

This project maps the competence gap related to border control. Based on this, the training curriculum in the area is updated, and courses and skill-development measures are implemented with participants from the police districts and coastguard.

The project is based on the concept of 'training the trainers', where the participants, after completing their education, receive a training package designed for conducting training in their own district. The project also establishes e-learning measures in the area of border control.

The implementation of the project has resulted in more efficient, targeted, high-quality border

control that facilitates the passage of legitimate travellers while contributing to the fight against cross-border crime and terrorism and preventing the entry of people who are not allowed to stay in the Schengen area.




## ISF Borders project: Purchase of night-vision goggles (PL/2018/PR/0021)

The aim of the project was to strengthen the protection and surveillance of the external border of the European Union.

The purchase of night-vision goggles resulted in the development of technical border protection systems for services carrying out tasks related to border and Schengen area protection. Night-vision goggles are used for terrain observation and detection and recognition of objects at the borders at night, increasing the level of security throughout the Schengen area. Night-vision goggles are most often used by motor and foot patrols.

Under the project 280 night-vision goggles were purchased (for use every day at the external EU borders) and in addition, as an integral part of the project, 24 service technicians were trained. These technicians have a multiplier effect in terms of training and perform maintenance on and supervise the proper use of the devices.

## Komponent ISF dotyczący granic: Zakup gogli noktowizyjnych (PL/2018/PR/0021)



Celem projektu jest wzmocnienie ochrony oraz nadzoru zewnętrznej granicy Unii Europejskiej.

Zakup gogli noktowizyjnych spowodował rozbudowę systemów ochrony technicznej granicy służb realizujących zadania związane z ochroną granicy i obszaru Schengen. Gogle noktowizyjne są wykorzystywane do obserwacji terenu oraz wykrywania i rozpoznawania obiektów w rejonach przygranicznych w warunkach nocnych, co podnosi poziom bezpieczeństwa na całym obszarze Schengen. Gogle noktowizyjne są wykorzystywane najczęściej przez patrole zmotoryzowane i piesze. Gogle noktowizyjne stanowią jeden z komponentów tworzących krajowy obraz sytuacyjny, wykorzystywany przez służby odpowiedzialną za ochronę granic zewnętrznych UE.



W ramach projektu został zakupiony sprzęt obserwacji technicznej i przeprowadzono szkolenie:

- zakupiono 280 gogle noktowizyjnych, które są użytkowane na zewnętrznej granicy UE,
- przeszkolono 24 techników serwisu.

## ISF Borders project: Acquisition and maintenance of operational equipment (PT/2017/PR/0137)

**Objectives.** Increasing internal security levels in the European Union; strengthening the operation and supervision of activities in the territorial sea; increasing maritime patrolling, search and rescue at sea, surveillance and coastal control capabilities.

**Main activities.** Repairs of vessels, notably through the replacement of engine components from various surveillance and control speed-boats, to enhance marine intervention capability; purchase of a cabin vessel; payment of fuel expenses resulting from maritime patrols in the region of Olhão.

It was therefore possible to ensure the timely maintenance of surveillance and control speed-boats, purchase a vessel and also equip vessels forfeited to the state through low-value investments, thus substantially enhancing the National Republican Guard's maritime capabilities.

## ISF Projeto «Fronteiras»: Aquisição e manutenção de equipamento operacional (PT/2017/PR/0137)

**Objetivos gerais.** Aumentar os níveis de segurança interna na União Europeia; reforçar a presença e fiscalização das atividades no mar territorial; incrementar as capacidades marítimas de patrulhamento, SAR, vigilância e controlo costeiro.

**Principais atividades.** Revisão mais aprofundada de embarcações, nomeadamente através da substituição de componentes do motor de diversas Lanchas de Vigilância e Intervenção — LVI, de forma que reforce a capacidade de intervenção em meio marítimo; aquisição de uma embarcação cabinada; pagamento das despesas de combustível resultantes do patrulhamento marítimo das embarcações da GNR (UCC).

Este projeto permitiu financiar custos operacionais (manutenção/reparação de embarcações, combustível e embarcação), que representam um valor considerável para a GNR, permitindo reforçar as capacidades marítimas da Guarda com o mínimo de esforço financeiro possível. Assim, foi possível garantir a manutenção atempada de LVI, adquirir uma embarcação cabinada e ainda equipar embarcações perdidas a favor do Estado, através de investimentos de valor reduzido, permitindo deste modo reforçar de forma substancial as capacidades marítimas da Guarda.



## ISF Borders project: Construction of the new headquarters for Isaccea Border Police Sector, Tulcea County (RO/2016/PR/0019)



The specific objectives of the project were to build new headquarters for the Romanian Border Police in Isaccea, Tulcea County, in order to optimise the organisation, bringing it in line with European-level standards, especially in terms of improving the working conditions and practices in the surveillance and physical control of Romania's border with Ukraine; to respond to the risks posed by cross-border crime; to increase the Border Police's capacity to carry out operational risk analyses; and, last but not least, to create the necessary conditions for increasing the border guards' capacity for intervention (involving a land component, a naval component and a canine component).

The expected impact of the project was the improvement of working conditions and an increase in the capacity for analysis and response at the Border Police Coast Guard.

Interestingly, during the construction works, an archaeological discovery was made (a Roman crypt). The artefacts were preserved and stored safely.

### Protect borders, facilitate travel

Many over-18 Swiss citizens or citizens of EU / European Free Trade Association states who hold biometric travel documents and who recently travelled between Switzerland and a third country by plane via Zurich Airport passed through the ABC gates. At these gates, the passport must be placed on a scanner, and facial recognition is performed. If the image taken corresponds with the data in the passport and the other entry requirements have been met, the gate opens: the traveller is free to cross the border.

In 2018, Zurich Airport registered 11 715 657 border crossings. Of those, 7 492 742 were Schengen border crossings and the ABC gates were used by 2 030 363 persons in total (on entry: 1 569 009; on exit: 461 354). This is above expectations. According to forecasts, the number will increase.

The existing border control processes are being supported by the introduction of new technologies in order to contribute to further increasing the protection of external Schengen borders and to combat irregular migration even more effectively. In addition to the reference system, a total of 13 ABC gates are in operation (eight on entry; five on exit).

As this pilot project has proven successful at Zurich Airport, the use of ABC gates is also planned at other airports in Switzerland (e.g. Geneva Airport).

### Grenzen schützen, Reisen erleichtern

Viele der über 18-jährigen EU-/EFTA- oder Schweizer Bürger mit biometrischen Reisedokumenten, die in letzter Zeit von einem Drittstaat per Flugzeug über Zürich in die Schweiz einreisten bzw. aus der Schweiz in einen Drittstaat reisten, durchschritten sie: die automatisierten Grenzkontrollschieleusen am Flughafen Zürich. Der Pass muss auf einen Scanner gelegt werden, es folgt die Gesichtserkennung. Sind der Abgleich zwischen der Aufnahme und den Daten im Pass positiv sowie alle anderen Einreisevoraussetzungen erfüllt, öffnet sich die Schleuse. Der Einreise steht nichts mehr im Weg.

Im Jahr 2018 haben am Flughafen Zürich 11 715 657 Grenzübertritte stattgefunden. 7 492 742 Übertritte davon erfolgten durch freizü-

gigkeitsberechtigte Personen (EU/Schengen). Die ABC-Gates wurden von insgesamt 2 030 363 Personen genutzt (Einreise: 1 569 009/Ausreise: 461 354). Damit liegt man über den Erwartungswerten. Die Prognose ist steigend.

Die bestehenden Grenzkontrollprozesse werden durch die Einführung neuer Technologien unterstützt, um den Schutz der Schengen-Außengrenzen weiter zu erhöhen und die illegale Migration noch effektiver zu bekämpfen. Neben dem Referenzsystem sind insgesamt 13 automatisierte Grenzkontrollschieleusen in Betrieb (acht bei der Einreise/fünf bei der Ausreise).

Da sich dieses Pilotprojekt am Flughafen Zürich als erfolgreich erwiesen hat, ist der Einsatz von ABC-Gates auch an weiteren Flughäfen in der Schweiz (z. B. am Flughafen Genf) geplant.
